The University

Sonoma State University's beautiful 274-acre campus is located in Sonoma County wine country, an hour north of San Francisco. The campus offers the ideal setting for teaching and learning and access to a community of rich cultural, environmental, and recreational opportunities. Founded in 1960, Sonoma State University is one of the 23 campuses of the California State University System. As members of the largest public

higher educational system in the nation, we provide accessible, high-quality education to more than 9,000 students. The Department

Majors in the Department of Chemistry may pursue a B.S in chemistry, (certified by the American Chemical Society), a B.S. in biochemistry or a B.A. in chemistry. A minor in chemistry is also offered. The Department's objectives include providing students with a broad, fundamental background in chemistry (in a liberal arts setting) and its applications to prepare them to work in industry or in research laboratories, pursue graduate study, or professional school. Many graduates go on to graduate schools, health professional schools or find employment in local industries. The Department also provides important courses in the University's general education program and supports other majors.

The Chemistry Department is currently composed of 5 full-time equivalent faculty members, 1.75 support staff, and approximately 140 majors. The Department emphasizes quality undergraduate instruction and offers considerable hands-on experience with close student-faculty contact in classes and in research. The curriculum has been designed to emphasize modern laboratory techniques. The department's advanced instrumentation includes a GC-MS, FT-IR, several HPLC instruments, UV-Vis and fluorescence spectrophotometers, AAS and FT-NMR (60 and 400 mHz). Also available in the Keck Microanalysis Laboratory are a scanning electron microscope with energy-dispersive x-ray analysis, two atomic force microscopes, an Auger spectrometer and an epifluorescent and laser scanning confocal microscope. The department primarily occupies a large part of the 3rd floor of Darwin Hall (approx. 9000 sq. ft., including faculty offices) as well as lab space in Carson Hall.

Duties of the Position

This position includes the responsibility for teaching of both lecture and lab courses, and the development of chemistry curriculum. Courses include but are not limited to the following: introduction to chemistry, general chemistry for science majors (both first and second semester), organic and biochemistry for science, nursing and kinesiology majors, chemistry and society for general education and inorganic chemistry. Candidates should be committed to teaching a diverse group of undergraduates including groups historically underrepresented and groups who may have experienced discrimination.

Professional Qualifications

To be recommended for appointment, the candidate must have:

Masters or PhD in a STEM field is preferred, although BA/BS degrees in STEM fields may also be considered.

Rank and Salary

Full-time is 15-unit workload per semester. Actual salary is dependent upon number of units assigned, educational preparation, and availability of funds subject to any CSU system faculty contract salary increases.

- Selection as a candidate in the applicant pool, does not guarantee employment. Temporary Faculty appointments are made on a part-time, temporary basis and contingent upon department needs and funding.
- Temporary Faculty appointments are made on a semester-by-semester basis.
- Relocation expenses will not be provided for temporary faculty appointments.
- Expenses incurred to attend an interview for temporary faculty positions are not reimbursed by the University.

Application procedures for temporary faculty already teaching in the department:

- Temporary Faculty with three-year contracts do not need to reapply.
- Temporary Faculty who have taught for the department within the past two years only need to submit a Lecturer Qualified Course Form and updated CV to remain

in the pool. The hiring committee will review the Personnel Action File and then determine whether an additional interview would be beneficial.

Sonoma State University hires only individuals lawfully authorized to work in the United States. All offers of employment are contingent upon presentation of documents demonstrating the appointee's identity and eligibility to work, in accordance with the provisions of the Immigration Reform and Control Act. Sonoma State University does not facilitate the process of applying for an H1B Visa for temporary positions.
