DUTIES OF THE POSITION

The Human Development Program anticipates a number of part-time, temporary teaching opportunities in human development. We are looking for individuals who can teach one or more of the following upper division, majors-only courses as needed on a semester by semester basis: Qualitative Research Design (4 units); Human Development Core Concepts (theory; 4 units); Applied Human Development (4 units); and a topical course in the applicant's area of specialization (4 units). Topics may include, but are not limited to, the following: disabilities across the life course, aging across cultures, globalization and the life course, the anthropology of childhood, the Latino life course, the anthropology of education, cultural psychology of human development, new media in the life course, social justice approaches to the life course, language socialization, sociocultural approaches to social work, and psychiatric anthropology.

The successful candidate/s must be able to work effectively and collaboratively in diverse, multicultural, and inclusive settings. Within these settings, the candidate must be committed to the academic success of all of our students.

Prior college teaching experience at T.A. level or higher. Evidence of an active learning approach to teaching.

Ability to work effectively with students of diverse backgrounds and perspectives.

RANK AND SALARY

Full-time is 15-unit workload per semester. Actual salary is dependent upon number of units assigned, educational preparation, and availability of funds subject to any CSU system faculty contract salary increases.

Application procedures for temporary faculty already teaching in the department:

- > Temporary Faculty with three-year contracts do not need to reapply.
- Temporary Faculty who have taught for the department within the past two years only need to submit a letter of intent to remain in the pool. The hiring committee will review the Personnel Action File and then determine whether an additional interview would be beneficial.

Sonoma State University hires only individuals lawfully authorized to work in the United States. All offers of employment are contingent upon presentation of documents demonstrating the appointee's identity and

eligibility to work, in accordance with the provisions of the Immigration Reform and Control Act. **Sonoma State University does not facilitate the process of applying for an H1B Visa for temporary positions.**
