# **DUTIES OF THE POSITION**

The Social Media Manager serves as the student lead in charge of KSUN's social media properties. This includes overseeing student staff, assigning leads for each platform, and ensuring regular posting of social media. In addition, the social media manager will facilitate communication with other KSUN managers and KSUN shows to ensure that show social media content gets re-posted on KSUN's primary social media properties. The Social Media Manager will also pursue strategies increase engagement, increase followers, and connect with other campus and community social media properties. The Social Media Manager will perform other duties as assigned.
