#### **DUTIES OF THE POSITION**

Attend regular Tuesday night classes and assist with class discussion and breakout teamwork, manage section or sections of the weekly paper which includes generating story ideas, assigning stories to reporters in your section and setting deadlines. On Fridays and weekends, you'll be editing the story submissions for your section for AP Style, accuracy, balance and adherence to journalistic principles, law and ethics. On Monday, you'll perform layout and design of weekly pages in your section, assigning weekly grades to student submissions using grading rubric, working with editors and photographers in team setting and posting stories to online website for STAR newspaper. Must also author two editorials per semester, deadlines TBD

### MINIMUM QUALIFICATIONS

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade, complete research, or tutor for a course. Admission or registration as a University student.
