# **DUTIES OF THE POSITION**

The students will work with faculty, staff and students within the Hughes Lab in the Biology Department at Sonoma State University Par of this position is learning scientific SCUBA diving techniques and data collection protocols to assist the Hughes Lab in subtidal data collection protocols. Part of this training will be working with our local SCUBA shop partner, SEALS Water Sports, to gather basic training protocols. The students will also actively get trained by Hughes Lab members on underwater data collection techniques. By the end of the semester the students will work on analyses of kelp forest community data from the data they collected during the spring. This project is funded by a grant through The Nature Conservancy and California Sea Grant (Q0404-1281-Q040401), and includes partners at San Jose State University.

# **MINIMUM QUALIFICATIONS**

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade, complete research, or tutor for a course. Admission or registration as a University student.
