DUTIES OF THE POSITION

Inspect insect collection for damage by dermestid beetles; review insect specimens submitted as coursework for inclusion into permanent insect collection in the Jack Arnold Museum; identify and relabel insect specimens as needed; maintain live insect colony; refill specimen containers with appropriate preservative. Work with students taking entomology to properly collect and label and identify specimens during spring 2026 semester.

MINIMUM QUALIFICATIONS

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade, complete research, or tutor for a course. Admission or registration as a University student. Note: Exceptions to the minimum eligibility qualifications may be granted at the sole discretion of the University.

HIRING CRITERIA

Experience working with insect specimens, successfully completing an undergraduate entomology course or gaining an equivalent level of experience through prior research and approval of supervisor.
