DUTIES OF THE POSITION

- Coordinating communications with faculty, students, and industry partners as needed.

MINIMUM QUALIFICATIONS

Completion of specific coursework may be required in order to teach, grade, complete research, or tutor for a course. Admission or registration as a University student.
