## **DUTIES OF THE POSITION**

The Supplemental Instruction (SI) Leader facilitates study groups attached to a parent course. SI Leaders conduct study sessions several times per week to review and reinforce instruction in the parent course. Duties include weekly observation of the parent course, collaboration with the instructor, planning and leading one-hour small group SI study sessions two days per week, and maintaining detailed records of activities and attendance for their sessions. SI Leaders will also produce effective study materials and structured activities to engage students in learning the course content of the course they support. SI Leaders duties may be conducted in-person and/or online, depending on campus needs.

SI Leaders model professional and collegial attitudes and behavior towards staff, faculty, and students; demonstrate appropriate standards of behavior regarding privacy, grades, and assignment expectations; and strive to create an environment that is welcoming and inviting for all students, faculty, and staff. Position requires attendance at pre-term SI Leader training sessions, and weekly or bi-monthly training meetings and regular reporting to the Tutorial /SI Coordinator. Position typically begins with required training (which may be as early as one week prior to the first day of classes); employment through the academic year is encouraged for SI Leaders.

In addition to providing academic support, SI Leaders serve as peer educators and campus leaders who develop transferable professional skills aligned with the NACE Career Competencies. Through session planning and facilitation, training, collaboration, and reflective practice, SI Leaders strengthen competencies in communication, teamwork, critical thinking, professionalism, equity and inclusion, leadership, and career and self-development.

## **MINIMUM QUALIFICATIONS**

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade, complete research, or tutor for a course. Admission or registration as a University student. Note: Exceptions to the minimum eligibility qualifications may be granted at the sole discretion of the University.

## HIRING CRITERIA

The SI Leader must possess a thorough knowledge of appropriate course material; have the ability to work with students from diverse cultural backgrounds and varying levels of skill development; have the ability to design and present instructional activities that support mastery of key concepts of the parent course; and demonstrate ability to communicate effectively with students, faculty and staff. Must demonstrate ability to work independently and meet deadlines. Must be punctual and be able to work at least 8 hours per week.

Must be an enrolled student at Sonoma State University, preferably of Junior or Senior status with a 3.0 overall GPA. SI Leaders are referred by the course instructor(s) or program's Department Chair. They must have completed the parent course previously with a grade of B or higher. They must have the ability to relate well to others, be able to analyze errors, design effective learning strategies to address different processing styles, and be able to teach good study strategies. Previous small group tutoring experience preferred.

- The classification, Instructional Student Assistant, is one of three classifications in a collective bargaining unit, Unit 11. Instructional Student Assistants, who must be currently enrolled University students, perform tutoring, grading, or teaching-related duties under the supervision of faculty or professional staff.
