DUTIES OF THE POSITION

Peer Mentors are assigned to faculty who teach in either First-year learning courses or Second-year experience courses. They work closely with the faculty to plan for the semester and support the students throughout their first or second year. They participate during all lectures and discussions of the course to deliver transitions content into academic curriculum wherever possible. In addition, Peer Mentors meet with each student for a one-on-one check-in at least twice each semester. Peers Mentors must attend weekly staff meeting on Fridays 1-2pm and hold weekly one-hour office hours.

MINIMUM QUALIFICATIONS

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade, or tutor a course. Admission or registration as a University student. Note: Exceptions to the minimum eligibility qualifications may be granted at the sole discretion of the University.

HIRING CRITERIA

Completion of UNIV 238 (B grade or better) is required for this position. A similar course or leadership experience may be substituted for this requirement. A cumulative GPA of 2.5 is required for this position.
