DUTIES OF THE POSITION

Major duties of the position include, but are not limited to, the following: The student assistant will work under the direction of the Principal Investigator (PI) and/or Co-Principal Investigator to support research on a current CAL FIRE and ARI grants. In the field, students will assist with measurements of aboveground biomass, fire fuels, and forest structure parameters using both traditional forestry methods and remote sensing approaches. In the lab, students will organize existing and new field data, process point clouds into various metrics and perform data analysis, field data entry, and producing graphs and figures for scientific papers.

MINIMUM QUALIFICATIONS

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade, or tutor a course. Admission or registration as a University student. Note: Exceptions to the minimum eligibility qualifications may be granted at the sole discretion of the University.
