### **DUTIES OF THE POSITION**

Students will work with SSU faculty and staff members and other students to interact with the local and wider community and let them know about our educational and research activities. This may involve producing displays for educational purposes and will involve discussing outreach displays with community members. Student will prepare posts to social media platforms that are used by students, parents, alumni, potential donors, and community members. Student will also work with staff of the Center for Environmental Inquiry to support events and collaborative outreach projects. During the academic year, students may participate in courses in the department of Biology that bring students to local natural areas to explore biological diversity and ecological processes. This participation may include driving vehicles with class participants to field sites. Support will be provided by an Instructionally Related Activities award to support student activities.

# **MINIMUM QUALIFICATIONS**

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade, complete research, or tutor for a course. Admission or registration as a University student.
