DUTIES OF THE POSITION

Major duties of the position include, but are not limited to, the following: The student research assistant will work under the direction of the Principal Investigator (PI) and/or Graduate Students to support research on current NSF, CALFIRE and CSU ARI grants. The undergraduate student research assistant may collect measurements of aboveground biomass, fire fuels, and forest structure parameters using both traditional forestry methods and remote sensing approaches in the field and use computer programs to process these data.

MINIMUM QUALIFICATIONS

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade, complete research, or tutor for a course. Admission or registration as a University student. Note: Exceptions to the minimum eligibility qualifications may be granted at the sole discretion of the University.

HIRING CRITERIA

Coursework in Biology or Computer Science or related field. Experience doing field work related to forestry and ecology applications is preferred. Ability to work outside in rugged conditions. Ability to work independently or in a team.
