DUTIES OF THE POSITION

Assist with video and podcast production.

- Coordinate and assist with Social Justice Week planning and hosting such as recruiting speakers, processing stipend information, drafting budgets, helping with advertising the event, writing op-eds, developing the website, and other tasks as needed.
- Co-host zoom sessions and help facilitate break out groups.
- Produce web and social media content.
- Attend class and meet once-weekly with the instructor of record.
- Assist with classroom technology, assist the professor with classroom discussion periods, and hold one weekly office hour to help students with questions/difficulties with material or course-related
 - assignments.
- Under the supervision and direction of the professor (at regular meetings), the ISA will assist with assessment student work.
- The ISA may also offer feedback to the professor about the flow, organization and clarity of course materials.

MINIMUM QUALIFICATIONS

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade, complete research, or tutor for a course. Admission or registration as a University student. Note: Exceptions to the minimum eligibility qualifications may be granted at the sole discretion of the University.
