- Start a "Social Justice" club on campus by working with staff and completing paperwork and recruiting student leadership.
- Coordinate and assist with Social Justice Week 2023 and 2024 conference planning and
 hosting such as recruiting speakers, processing stipend information, drafting budgets, helping
 with advertising the event, writing op-eds, developing the website, and other tasks as needed.
- Produce web and social media content.
- Attend Spring 2024 class and meet once-weekly with the instructor of record.
- Assist with video and podcast production

MINIMUM QUALIFICATIONS

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade, complete research, or tutor for a course. Admission or registration as a University student. Note: Exceptions to the minimum eligibility qualifications may be granted at the sole discretion of the University.

HIRING CRITERIA

The student should be available until May 2024. The position will be renewed in Summer 2023, Fall 2023, and Spring 2024.

A student who has demonstrated proficiency in the subject matter and is familiar with SSU's Social Justice Week. Excellent communication skills. Available for short periods of intensive work. Preference for podcast and video production skills, and/or social media and website skills.
