### **DUTIES OF THE POSITION**

The graduate assistant will assist faculty in various research projects in the field of counseling and psychology. The graduate assistant will be responsible for **conducting literature searches**, **data management**, **recruiting participants**, **obtaining consents**, **maintaining files**, **assisting with IRB**, **scheduling and conducting interviews**, **maintaining data collection files**, **assisting with write ups**, **locating appropriate and relevant grant sources and assisting with grant writing**. Graduate assistant will also be expected to manage undergraduate-level students involved in research projects.

Ability to create and maintain spreadsheets and word documents; strong organizational skills; strong written and oral communication skills; and strong attention to details. Preferred qualification: sufficient relative experience to be able to perform research independently and without major guidance..

### MINIMUM QUALIFICATIONS

Knowledge of the subject matter of the discipline in which assigned. For initial appointment, evidence of satisfactory achievement in previous academic work; for the subsequent appointments, evidence of satisfactory progress toward completion of degree. Education equivalent to completion of the requirements for a bachelor's degree and registration in a University graduate degree program; students enrolled in credential programs are not eligible for this position. NOTE: Exceptions to the minimum eligibility qualifications may be granted at the sole discretion of the University.
