DUTIES OF THE POSITION

MACH is the abbreviation for: Magnetic fields, Atmospheres, and the Connection to Habitability

Student will support deadlines for EdEon's MACH grant-funded projects, specifically on websites and with scientific data converted for spherical displays for team and public learning modules. Student hire also supports our core mission to include students in our research and development projects, make student hiring vital to complete on our grant-funded work.

"Do habitable worlds require magnetic fields?" – This simple six-word question poses a relevant and timely challenge for the field of Heliophysics, and has the potential to engage both laypeopleand experts. The Magnetic fields, Atmospheres, and the Connection to Habitability (MACH) DRIVE Science Center (DSC) will determine whether a global magnetic field is essential for a planet to retain a habitable atmosphere. Atmospheric escape occurs via several physical processes; our Phase I effort is focused on constructing tools to evaluate the influence of a global dipole field on the escape of charged particles, with emphasis on the terrestrial planets Venus, Earth, and Mars.

This student would be able to do this work remotely at home, and would currently have home-based technological solutions and space at home. Our team has a process for safely getting new technologies to team members when needed.

MINIMUM QUALIFICATIONS

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other student; and accept responsibility.
