DUTIES OF THE POSITION

The student assistant will work under the direction of the Principle Investigator (PI) Dr. Matthew Clark to support research on the multiple grants. Computer work will be mainly remote, with access to computers in the Center for Interdisciplinary Geospatial Analysis (CIGA) at Sonoma State via a remote connection as needed. Duties include helping collect data from an unoccupied aerial system (UAS, drone) and terrestrial laser scanner (TLS) data in field locations, process UAS and TLS data, assessing patterns of wildfire and bird diversity using geospatial analysis, collection of reference data for machine learning analyses, preparing maps and figures for scientific publications, and literature review.

MINIMUM QUALIFICATIONS

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade, complete research, or tutor for a course. Admission or registration as a University student. Note: Exceptions to the minimum eligibility qualifications may be granted at the sole discretion of the University.

HIRING CRITERIA

Knowledge of ArcGIS Pro GIS software. Ability to work in field conditions, including hiking to off-trail locations in forested conditions in varying weather conditions. Organized, communicative and motivated to acquire new skills and knowledge and willingness to work independently or in a team. Desired: Computer programming in python or R.
