DUTIES OF THE POSITION

The student assistant will work under the direction of the Principal Investigator (PI) Dr. Matthew Clark to support research on the NASA-funded BioSoundSCape project. Computer work will be mainly remote, with access to computers in the Center for Interdisciplinary Geospatial Analysis (CIGA) at Sonoma State via a remote connection or in-person as needed. Duties include: collecting reference data for soundscape components (anthropophony, biophony, geophony, and interference); training a convolutional neural network (AI) algorithm to automatically detect soundscape components in a large sound recording archive; apply pre-trained CNNs the sound recordings to extract acoustic features; and, assist in statistical analysis of soundscapes with acoustic features

MINIMUM QUALIFICATIONS

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade, complete research, or tutor for a course. Admission or registration as a University student. Note: Exceptions to the minimum eligibility qualifications may be granted at the sole discretion of the University.
