## **DUTIES OF THE POSITION**

- Provide academic support to all Sonoma State students for lower-division School of Science & Technology courses.
- Attend bi-weekly training and check-ins with the other tutors and MESA staff (dates and times TBD).
- Assist with promotional tasks such as posting flyers and contacting professors.
- Be available to tutor for at least two monthly MESA Study Halls (Tuesdays 5 PM 6 PM & Thursdays 12 PM – 1 PM).
- Be available to tutor for at least two of our end-of-semester tutoring sessions (evenings the week before finals).

### MINIMUM QUALIFICATIONS

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade, complete research, or tutor for a course. Admission or registration as a University student. Note: Exceptions to the minimum eligibility qualifications may be granted at the sole discretion of the University.

### HIRING CRITERIA

Applicants must be in good academic standing and a member of MESA at Sonoma State University. Applicants are welcome to apply to join MESA before applying to this position if they are not already a MESA member.

- The classification, Instructional Student Assistant, is one of three classifications in a collective bargaining unit, Unit 11. Instructional Student Assistants, who must be currently enrolled University students, perform tutoring, grading, or teaching-related duties under the supervision of faculty or professional staff.
