DUTIES OF THE POSITION

- Provide mentoring support for MESA members

- Present 2 STEMbyte presentations each semester in subject matter relating to student success
- Lead different MESA specific projects such as: outreach, marketing, social media, newsletter, senior project, student opportunities sheet, etc.
- Assist with promotional tasks such as posting flyers, tabling, and classroom visitations.

MINIMUM QUALIFICATIONS

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade, complete research, or tutor for a course. Admission or registration as a University student. Note: Exceptions to the minimum eligibility qualifications may be granted at the sole discretion of the University.

Instructional Student Assistants, who must be currently enrolled University students, perform tutoring, grading, or teaching-related duties under the supervision of faculty or professional staff.
