## DUTIES OF THE POSITION

Inspect insect collection for damage by dermestid beetles; review insect specimens submitted as coursework for inclusion into permanent insect collection in the Jack Arnold Museum; identify insect specimens as needed; maintain live insect colony; refill specimen containers with appropriate preservative. Curator will participate in outreach activities and may help produce displays for educational purposes to discuss with community members. Assistant will work with Center of Environmental Inquiry to support events and collaborative outreach projects.

## MINIMAL QUALIFICATIONS

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade, complete research, or tutor for a course. Admission or registration as a university student.
